(Covid-19)

Guidance for Applicants

Process for the issue of Temporary Pavement Cafés Licenses during Covid-19 pandemic

From 1st April 2021 Causeway Coast and Glens will be ensuring compliance with the Licensing requirements of the Pavement Cafés Act (Northern Ireland) 2014 as part of the economic revitalisation of the hospitality sector.

In this regard a streamlined process and the issue of a **conditional temporary licence from the date of application to 31st March 2022** will be afforded to those premises that make an application to place tables and chairs in an outside space adjacent to their fixed premises and can comply with the necessary conditions to safeguard pedestrians and other road users.

In order to obtain a licence the following is required:

Application form – Fully completed, signed and dated. There is no application fee for a temporary pavement café licence.

Location plan – A plan must be provided to a scale not less than 1:2500 (preferably ordnance survey) showing the proposed pavement café marked in red and the adjoining streets and properties to enable consideration of all related issues.

Site plan – A plan must be provided to a scale of not less than 1:100 of the proposed pavement café area, the streetscape and all utilities and services including lampposts, bollards, fire hydrants, manholes, cycle stands, litter bins and any other items of street furniture located within the immediate vicinity. The dimensions of the proposed pavement café area must also be shown. The number of tables and chairs and barriers must also be included.

Barriers - The pavement café area must be enclosed with the exception of a break for ingress/egress to prevent pedestrians with sight loss/visual impairment entering the café area, with proposed barriers tapered back to the building line at both ends. Details/photos of the barriers used to ensure enclosure must be forwarded too. Portable, sturdy barriers with a tap rail are recommended. Bases should not cause an obstruction or tripping hazard to pedestrians.

Details of the furniture – Provide details of the number, materials and types of chairs, tables, umbrellas to be provided in the café. Include photographs, manufacturer, and detailed brochures of proposed furniture or photographs of existing furniture.

Risk Assessment - Applicants are reminded of their duties, to carry out a risk assessment, under the Health and Safety at Work (NI) Order 1978 as they relate to the area and activities covered by the pavement café. The risk assessment must include Covid - 19 measures.

Public Liability Insurance - With a minimum £5 million indemnity.

Notice of Application Fixed to Premises - To be erected on the day the application is submitted to Council and displayed for the whole of the period of 28 days in a prominent place at or near the premises so that it can be conveniently read by the public. An applicant must either email or include with application a photograph of this displayed notice as it appears at the premises. Interested parties can make representations to the Council in respect of an application. In addition, a Council will make the application details available to be viewed by the public on its website until the end of the period allowed for representations. You must complete the declaration on the application form stating that you have erected the required notice and that you will maintain it in place for 28 days from the date of application.

Consultations

As part of the application process Council will conduct a 28 day consultation with the Department for Infrastructure, The Planning Department and if a licensed premises with the PSNI and any other relevant organisations/individuals before a decision is made as to whether or not a Temporary Pavement Café Licence will be issued.

Please note that the grant of a temporary licence should not infer that a permanent licence will be issued.

Council aims to make a determination within 8 weeks from the receipt of a completed application.

If an application for a temporary licence is refused the applicant will be informed. An applicant can appeal to the Magistrate's Court within 21 days of Council's notification of refusal.

If a business operator fails to submit an application for a temporary pavement café licence and operates an unlicensed pavement café this will be deemed to be an offence and subject to Councils current Enforcement policy Operators may be liable to a fine of up to £1,000 on summary conviction.
